## God is Prochoice.

WHAT! God favors abortion. Let's go back to definitions. Prochoice means favoring the ability to choose. God created human beings with the ability to make choices. He didn't have to. It was His choice to do so.

He made human beings in His image, and it apparently includes the ability to choose as well as to think and communicate.

He also made creatures without choices. Plants' leaves reach out to the sun and their roots seek water. Animals operate mostly on instincts, although your dog seems to choose to love you as much as your cat chooses to tolerate you.

Avoiding trouble by telling lies is always a potential choice but telling the truth is also available and the advantages of truthfulness ought to be clear to anyone who thinks it through.
